Contributions for national/regional eea pilot programmes

For pilot national/regional trustees

Pilot trustees are considered to be pilot trustees generally for a maximum of 3 years. If - after 3 years - the trustee still needs more time to establish national structures and a national financing scheme, the trustee may request a prolongation of its pilot status for another 2 years with the eea Board .

Pilot trustees shall pay the following contributions to the Association eea:

- pilot membership contribution, due once a year
- flat-rate license contribution
- consulting costs for a mandatory quality management and strategy package to be carried out by the eea office. The aim of the quality management and strategy package is to back-up the International eea Country Advisor regarding quality assurance and to align the eea development in the pilot country with the strategic development of the Association eea.
- additionally the pilot trustee needs to mandate an accredited International eea Country Advisor to coach the implementation of the eea in a new country/region and (an) accredited International eea City Advisor(s) to carry out the eea process in the first 2-3 pilot cities. (The accredited International eea Country Advisor may be the same person as the accredited International eea City Advisor.)

- coaching of the International eea Country Advisor regarding most recent developments of the eea instruments and processes
- feedbacks to and check of the newly developed eea catalogue and assessment guidance of the pilot country
- coordination of initial technical installation of the EMT country section
- support of the pilot trustee in the name of the Association eea as regards the national anchoring of the eea programme, incl. 1 meeting with important national stakeholders in the respective country
- linking of the new national stakeholders with eea Board members and other national eea trustees
- provide support in difficult project phases to the International eea Advisor(s) and the pilot trustee

*** Additional costs for an eea implementation project on national level include typically travel expenses, translation costs, auditor costs for certification of municipalities. Generally, daily rates of International eea advisors should not be higher than 1'100 €/day*
